1. Subject of the Licence

BULGARGAZ EAD, the holder of this licence, in accordance with the provisions of the Act, as in force, and the conditions that follow, acquires the right to sell natural gas to end customers in accordance with Article 34 of the Licensing Regulation.

BULGARGAZ EAD, the holder of this licence, is entitled to supply natural gas to end customers, both through the transmission system and/or the distribution network and outside the transmission system and the distribution network, on the basis of the data included in the Business Plan it has submitted to the Regulatory Authority for Energy in accordance with the Licensing Regulation, Annex VI, Part Two.

2. Compliance with the terms and conditions of the Licensing Regulations for the Supply Licence

The Supply Licensee shall comply with the provisions included in the Licensing Regulations, Section II, Appendix I.

3. Compliance with the special conditions of the Supply Licence Regulations

The Delivery Licensee undertakes to comply with the provisions included in the Licensing Regulations, Section II, Schedule 6.

4. Modification of the licence

The supply licence may be varied in accordance with Articles 17 and 18 of the Licensing Regulations.

5. Withdrawal of the licence

The supply licence may be revoked in accordance with the provisions of Article 20 of the Licensing Regulation.

Pursuant to the provisions included in Article 32, paragraph 2 of Law 4001/2011, an application for review may be filed against the decisions of the Energy Regulatory Authority within thirty (30) days from the time of publication or announcement of the decision.
